Human Clinical Study #1

Publication: Effect of Grape Seed Extract on Blood Pressure in Subjects with the Metabolic Syndrome¹

Study type: randomized, double-blind, placebo-controlled

Design: Twenty-five subjects were randomized into three groups: a.) placebo, b.) 150 mg MegaNatural-BP per day and c.) 300 mg MegaNatural-BP per day. Each group took their respective treatment for four weeks.

Results: Blood samples showed MegaNatural-BP to be well-absorbed after a single dose, with a steep rise in polyphenols 90 minutes after ingestion. At the end of four weeks, both dosages of MegaNatural-BP were found to help maintain blood pressure levels (both systolic and diastolic) within the normal range.*



Publication: Effect of Grape Seed Extract in Subjects with Pre-Hypertension²

Study type: randomized, double-blind, placebo-controlled

Design: All 30 subjects began the trial by taking a placebo for two weeks. Then, they were randomized into two groups: a.) placebo and b.) 300 mg MegaNatural-BP per day. Each group took their respective treatment for eight weeks.

Results: At the end of eight weeks, MegaNatural-BP was found to help maintain





blood pressure levels (both systolic and diastolic) within the normal range.*

Human Clinical Study #3

Publication (submitted): Effects of grape seed extract beverage on blood pressure and metabolic indices in individuals with pre-hypertension: a randomized, doubleblinded, placebo-controlled trial3

Study type: randomized, double-blind, placebo-controlled

Design: All subjects began the trial by taking a placebo for two weeks. Then, they were randomized into two groups: a.) fruitjuice beverage (placebo drink) and b.) fruitjuice beverage with 150 mg MegaNatural-BP. Beverages were drank twice per day for a total dose of 0 mg or 300 mg MegaNatural-BP. Each group took their respective beverages for six weeks then discontinued for an additional four weeks when a final follow-up assessment was conducted. Subjects were on study for 12 weeks total.

Results: Consumption of MegaNatural-BP beverage for six weeks led to a significant reduction in systolic BP compared to placebo beverage that returned to baseline after four week discontinuation of GSE beverage. Similar findings were apparent for diastolic BP, showing 4.7 percent reduction in DBP that returned to baseline after discontinuation of GSE beverage. Subjects with higher starting BP experienced greater BP reduction, which nearly doubled the effect size. Changes in fasting insulin and insulin sensitivity as calculated by HOMA-IR tended to be improved after six weeks of GSE beverage, suggesting metabolic effects of MegaNatural-BP.*

MegaNatural-BP has also been the subject of two published safety studies. After submitting the studies to the FDA (U.S. Food and Drug Administration), MegaNatural-BP received No-Objection GRAS (generally recognized as safe) status. Clinical studies confirm that MegaNatural-BP is free of side effects. Every lot is rigorously tested to ensure purity and safety. MegaNatural-BP is manufactured through a patented hot-waterbased-extraction process, with no traces of toxic chemicals or solvents in the final ingredient. 
